STUDENT RIGHT TO CANCEL

The student has the right to cancel the enrollment agreement or withdraw from the program and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later. If a student withdraws totally from the program, the student will receive a refund within thirty days from the date of withdrawal.
